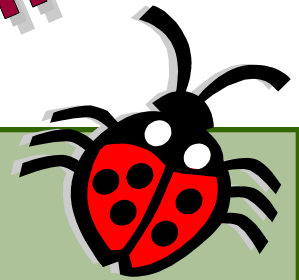

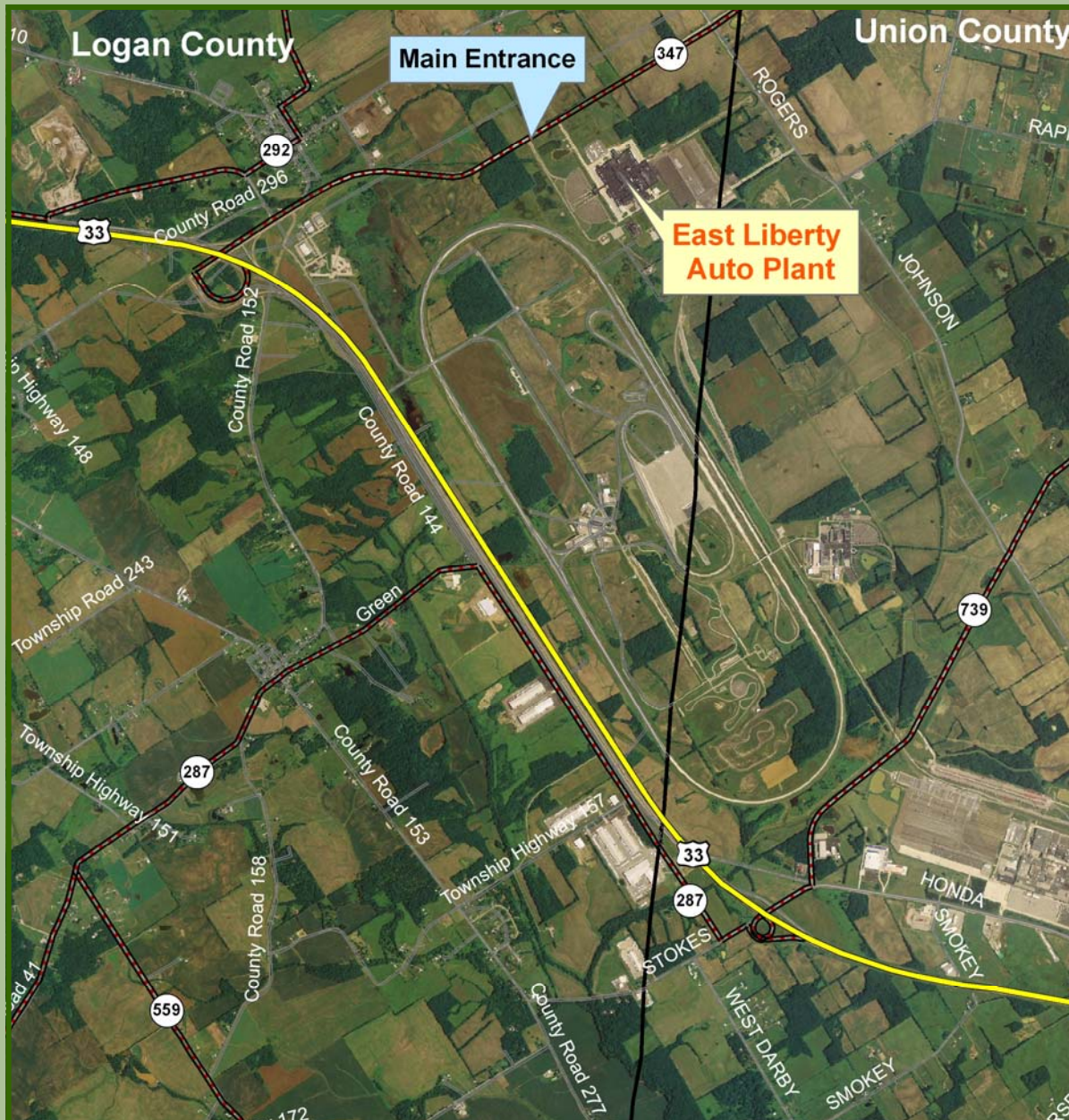

Arrival at Site

Stop at security gate to review previously submitted roster with who is on bus. Adults will need a drivers license. These may be checked. Follow signs that lead you back to actual event location.
